- Receive an annual tax report from OC

Automated giving is one way to express an ongoing commitment which empowers your missionaries in their jobs.



Contributions are received with the understanding that OC has complete discretion and control over the use of all donated funds. This is to ensure that your gift is fully tax-deductible under IRS rulings.

OPTION #1

Recurring Monthly Auto Bank Transfer (EFT)

This is a safe way to contribute, free of any charges, and requiring minimal administrative processing for OC. To do this, please send in a voided check with the tear-off form provided. Checking account transfers are processed on the 15th or 30th of the month.



OPTION #2

Recurring Monthly Credit Card Transfer

To set this up, fill out the tear-off form and mail it to OC. Or, go to OneChallenge.org/give, and fill out the online form. Credit card donations cost OC a **3.5% bank processing fee**.
